### POLICY LATEST.

### ► Defence & Security

Shipping Defence Advisory Council (SDAC) attended by cross HMG departments and the international industry, is working on international shipping voluntary security reporting standards; a review of how commercial shipping could support a deployed Royal Navy (RN) in contingent operations and increasing the understanding of commercial and naval operations through the Maritime Engagement Forum.

### **Employment**

Current areas of discussion include the upcoming comprehensive review of the STCW Convention; the implementation of the Seafarers' Wages Act (2023) and the Equality Act (2011); and improving the prospects for UK seafarers within the industry.

### ► Safety & Environment

The Chamber has published a Net Zero decarbonisation framework which outlines the members' collective policy on the route to Net Zero by 2050.

A **Safety of Alternative Fuels Working Group** has been established to review the safety of new and alternative fuels and attempting to ensure that regulations for the handling and storage of these fuels is introduced in a timely manner.

A working group to gather knowledge of the fire and explosion hazards associated with **Lithium Ion Batteries (LIBs)** has been established to develop policy in national and international regulations for their carriage, as cargo or in electric vehicles.

The Chamber has joined the **Together in Safety** initiative. This creates new opportunities for how we can collaborate in improving safety – a current key strategic objective.

#### International Trade & Tax (ITTC)

This committee comprises three working groups (WG):

- The International Trade and Customs WG which is working on border controls and trade barriers.
- The Sustainability Finance and Reporting WG looking into ESG reporting and transition finance regulations/alliances.
- The **Tax WG** continues to review Tonnage Tax and other taxes which affect the investment and operation of commercial shipping.

# Chamber calls for a long-term plan to decarbonise shipping



The UK Chamber of Shipping and seven other maritime trade bodies have written to maritime minister Mike Kane to call for a successor to the Clean Maritime Plan to be an early and top priority.

The entire maritime sector is committed to reducing its carbon footprint and achieving net zero. However, it does require a long term plan that sets the framework for how government and the sector will work together to reduce emissions.

The 2024 General Election meant that the planned refresh of the Clean Maritime Plan, first published in 2019, was curtailed meaning that it is vital the new Government treats publication of a new multi year plan as a top priority.

Commenting on the letter UK Chamber of Shipping CEO Rhett Hatcher said:

"It is vital to provide the industry and investors with confidence to aid the sector in its drive to reach net zero. To achieve this, we need a multi-year plan, which creates a framework for public and private sector collaboration and a pathway for emissions reduction.

"The previous plan, published in 2019 is long overdue for review and the Government must now undertake this, alongside industry, as a top priority to ensure that maritime sector does not fall behind in reducing emissions."



## Chamber meets new Maritime Minister

In September Chamber President JB Rae-Smith and Chief Executive Rhett Hatcher met new Maritime Minister Mike Kane MP.

The meeting was an opportunity to build on the strong relationship the Chamber had already established during the Minister's time as Shadow Maritime Minister.

Rhett and JB took the opportunity to discuss the Chamber's three 3Ps of people, planet and prosperity and speak to the Minister about how shipping is central to delivering economic growth across the country and enabling a green energy revolution.

Speaking after the meeting Rhett said:

"I am pleased to meet the Minister so early into his tenure.

"With the shipping industry keen to help the Government deliver its economic growth and green energy missions in particular, I look forward to ongoing engagement with the Minister and his team in the weeks and months ahead, on key issues for our industry."

## Shipping sets out £700m of net zero investment priorities

The UK Chamber of Shipping has outlined a roadmap for the UK shipping industry to reach net zero by 2050, with a proposed £700m investment in the upcoming Budget to help make the UK a hub for clean shipping.

Key to this plan is cooperation between the industry and government to update the 2019 Clean Maritime Plan, to quide emission reduction efforts.

The Chamber has made several recommendations to the government, highlighting areas where public investment can unlock significant private funding:

- Continuing research and development funding through UK SHORE.
- ▶ Providing shore power so ships can plug in at ports instead of running their engines.
- Protecting essential ferry services from costly emission trading scheme fees until they can fully decarbonise.
- ▶ Ensuring the UK maritime sector has the necessary skills and workforce for the future.

### We chat about his role at Hovertravel

### Q Tell us about your role at Hovertravel?

NC | My role as Managing Director is to oversee the company's day-to-day operations and strategic goals. I am responsible for the overall safety and performance of the company with three key areas: implement the business strategy, champion the company culture and ensure its financial stability.

#### Q In a few words, how would explain what Hovertravel do?

NC | Hovertravel is the world's only year-round, scheduled passenger hovercraft service. We connect the UK mainland to its most popular island, the Isle of Wight, with the fastest foot passenger ferry service. We transport people, patients and parcels across the Solent in under ten minutes.

### Q How did you get into the industry?

**NC** | Originally working on the high street for national travel agency chain, Lunn Poly, I ran a company providing flight only and airport representation at Gatwick Airport and then was asked to join Hovertravel.

### Q What do you enjoy most about your role?

NC | I am honoured to be delivering a safe, and outstanding level of customer service with a fleet of vessels which is unique within the hugely varied maritime industry. Additionally being the first marine operator to be recognised as achieving leader status in the Government's Inclusive Transport Leaders Scheme was a

significant step in our accessibility journey. Finally the ability to diversify our operation to meet evolving customer and community requirements, including becoming a critical lifeline service is very rewarding to myself and my team.

#### Q What do you think the key benefits are of Chamber membership?

NC | The Chamber offers us, as a relatively small company, the opportunity to directly engage with individuals and organisations who are influencing policy decisions. Our voice is part of the collective industry approach and, in that process, the sharing of best practice aids our own continuous improvement.

### **Q** Tell us one thing you would change in the shipping industry?

**NC** | I would like see the industry and the wider community work further together to make shipping an aspirational career choice for people of all ages and backgrounds.

### Q Why aren't hovercraft used more?

**NC** | Hovercraft are in operation widely around the globe, albeit not in highly visible roles. Hovercraft are used by militaries for defence and search and rescue operations, whilst several overseas coastguards and border patrols deploy hovercraft too, as do some of our own RNLI stations. Their reduced environmental impact also make hovercraft the ideal craft for surveying delicate habitats. In the next few months, three new passenger hovercraft will be in operation in Oita, Japan, all designed and built here in the UK.

### **Q** What is Hovertravel's biggest asset?

**NC** | I am sure the majority of people would expect me to say the unique nature of the hovercraft is the biggest asset but from my perspective, and mentioned most often in our customer reviews, it is the team of amazing people who work at Hovertravel.

### Q | What does Stella Maris do for seafarers?

**TH** | As the world's largest ship-visiting network we support seafarers with practical, pastoral and spiritual support in 57 countries and over 350 ports globally. At the cornerstone of all our support is one thing: face-to-face interaction. Our people have years of experience of day-to-day ship visiting so they know how to provide practical help and advice. But we also bring a warmth of care that seafarers simply can't get from an employer or a helpline.

### Q | What is your role?

**TH** | As CEO and National Director of Stella Maris, my role is to provide leadership and guidance to our network of chaplains across the UK, and to represent the charity both nationally and internationally. I firmly believe that we achieve the most through collaboration, which is why building strategic alliances with maritime stakeholders to create a unified voice for the People of the Sea is essential in addressing their needs. I see my role as a key part of this effort.

#### Q | What are your current initiatives?

**TH** | We believe that every seafarer and fisher deserves to live a happy, safe, fair and fulfilling life. So in addition to our day-to-day support, we amplify the voice of seafarers and fishers by advocating on their behalf. Exploitation has no place in the maritime industry – but it's an issue we can't tackle alone. We are leveraging our unique position to highlight modern slavery, give fishers a voice, and bring agencies together to work for change.

We are also mindful of the unique challenges faced by many Ukrainian seafarers and their families due to the war. To support them, alongside our emergency grants available to all seafarers, fishers and their families facing unforeseen hardship, we are offering financial resilience training and mental health support. This will equip participants with financial skills, boosting their morale and confidence as they look ahead to the future.

### Q How can members support your charity?



## A charity insight into The Mission To Seafarers

### Q | Can you give us an overview of the work of The Mission to Seafarers?

PR | The Mission to Seafarers provides help and support to the 1.89 million men and women working at sea, of all ranks, nationalities and beliefs, with our presence in over 200 ports and 50 countries. Through our global network of chaplains, staff and volunteers, we strive to offer practical, emotional and spiritual support to seafarers and their families through ship visits, drop-in seafarers' centres and a range of welfare and emergency support services, including a growing number of digital welfare solutions.

### Q | What is your role?

PR | I'm relatively new to the role of Secretary-General, having joined the Mission in July. I enjoyed several weeks of handover with my predecessor, Andrew Wright, before formally stepping into the role. My first priorities are to empower our team to continue their vital work in supporting seafarers around the globe, to encourage fresh thinking to how we can tackle the emerging challenges faced by those working at sea, and to serve as a champion for all seafarers in what can be a turbulent world.

I've also been learning lots more about the maritime industry every day, spending time with my colleagues, and visiting our seafarer centres in the UK and elsewhere in the world to see first-hand the wonderful services that are delivered by our staff and volunteers. Add to this the extensive contacts that are rapidly developing for me with companies involved in the diverse shipping industry, and with regulatory bodies, and you will see that these past few months have been a very busy, but also hugely enjoyable period.

### **Q** | Give us an example of your campaigns or initiatives to support mariners?

PR | There's so much we could talk about! Investing in our digital welfare solutions has been an important area for us. We will never underestimate the foundational significance of face-to-face interactions. Our experience is that not only in times of crisis, but also on the day-to-day business of life at sea, our in-person

work remains vital. Nevertheless, digital technologies can play a crucial role in widening the range and accessibility of the support we offer to seafarers, and at times their families. Our free 'Happy at Sea' app is a great example of a tool that seafarers can use to access digital welfare resources, check which ports we are present in, submit requests for support, complete our happiness index survey which acts as a barometer for the wider industry on seafarer wellbeing, and more.

### Q | How does Chamber membership help with the Mission's work?

PR | As you will have seen, our partnership with the wider shipping industry is not accidental to what we do, but an intrinsic part of the support we can provide for seafarer wellbeing. Membership of the Chamber is therefore of particular significance in being a part of the UK shipping community, listening and learning from the perspectives of our fellow members, building relationships and also sharing our knowledge and expertise on the experiences of seafarers, both in the UK and globally.

### **Q** | How can Chamber members get involved with your work?

**PR** | There are many ways for members to get involved and support our vital work. We work with a number of our corporate partners to deliver bespoke programmes and initiatives that support their seafarers and help to meet their CSR obligations. **PR** | My wife Tracey and I live in Sheffield, and we share our home with a Ukrainian family escaping from the war in their homeland, and an eccentric Brittany Spaniel called Jaffa.
